#### **PURPOSE OF PROCESSING**

In particular, your data will be processed for purposes related to the implementation of obligations relating to legislative or contractual obligations:

- advanced navigation purposes or personalized content management;
- purposes inherent to the execution of a contract or the execution of pre-contractual measures adopted upon request (e.g. contact request via the Contact form, possible registration for the services offered by the undersigned, etc.);
- purposes necessary to ascertain, exercise or defend a right in court or whenever the jurisdictional authorities exercise their jurisdictional functions;
- purposes of statistical research/analysis on aggregate or anonymous data, therefore without the possibility of identifying the user, aimed at measuring the functioning of the Site, measuring traffic and evaluating usability and interest.

The processing of functional data for the fulfillment of these obligations is necessary for the correct management of the relationship and their provision is mandatory to implement the purposes indicated above. The Data Controller also informs you that any non-communication, or incorrect communication, of any of the mandatory information may make it impossible to guarantee the adequacy of the processing itself.

## **LEGAL BASIS OF THE PROCESSING**

The personal data indicated on this page are processed for the sole purpose of providing the service or provision requested.

#### TYPES OF DATA PROCESSED AND PURPOSE OF THE PROCESSING

#### **Browsing data**

The computer systems and software procedures used to operate this site acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This category of data includes the IP addresses or domain names of the computers used by users who connect to the Site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment. This data is used for the sole purpose of checking the correct functioning of the Site.

These data, necessary for the use of web services, are also processed for the purpose of:

- obtaing statistical information on the use of services (most visited pages, number of visitors per time slot or day, geographical areas of origin, etc.);
- check the correct functioning of the services offered.

The navigation data do not persist for more than seven days and are deleted immediately after their aggregation (except for any need for the investigation of crimes by the judicial authority).

The optional, explicit and voluntary sending of messages to contact addresses, as well as the compilation and forwarding of the forms on the site, involve the acquisition of the sender's contact data, necessary to respond, as well as all personal data included in communications.

Specific information will be published on the pages of the sites set up for the provision of certain services.

## **COOKIES AND OTHER TRACKING SYSTEMS**

No cookies are used to profile users, nor are other tracking methods used.

Instead, session cookies (non-persistent) are used in a manner strictly limited to what is necessary for safe and efficient navigation of the sites. The storage of session cookies in terminals or browsers is under the control of the user, whereas on the servers, at the end of HTTP sessions, information relating to cookies remains recorded in the service logs, with retention times, however, not exceeding seven days like other navigation data.

### **RECIPIENTS OF THE DATA**

The recipients of the data collected following consultation of the sites listed above are the following subjects designated by the undersigned, pursuant to Article 28 of the Regulation, as data controllers: GRUPPO 4 S.R.L., via G. ## **DISSEMINATION OF DATA AND PLACE OF PROCESSING**

Your personal data will not be disclosed in any way.

The computer archives on which the above data are processed are located within the European Union. Personal data is not transferred outside the European Union.

Where necessary, however, the Data Controller will have the right to move the location of its computer archives to non-European countries. In this case, the Data Controller immediately ensures that the transfer of data outside the EU will take place in compliance with the applicable legal provisions by stipulating, if necessary, agreements aimed at guaranteeing an adequate level of protection and/or adopting the standard contractual clauses envisaged by the Commission. European.

#### RIGHTS OF THE INTERESTED PARTY IN REFERENCE TO DATA PROCESSING

Pursuant to articles 15, 16, 17, 18, 19, 20, 21, and 77 of the EU Regulation, the interested party is informed that:

- they have the right to request access to personal data, rectification, cancellation of the same or limitation of the processing that concerns him or to oppose their processing, and the transfer of his data to another owner in the foreseen cases;
- any corrections or cancellations or limitations of processing carried out at the request of the interested party unless this proves impossible or involves a disproportionate effort - will be communicated by the Undersigned to each of the managers to whom the personal data were transmitted;
- they have the right to lodge a complaint with the Guarantor for the protection of personal data, following the procedures and instructions published on the Authority's official website at www.garanteprivacy.it.
